Sub: Non-applicability of Disclosure under Regulation 23(9) and 24(A) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015- Disclosure of Related Party Transactions on a consolidated basis for the half year ended March 31, 2024 and Annual Secretarial Compliance Report for the financial year ended March 31, 2024

We would like to inform you that pursuant to Regulation 15(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Compliances with the Corporate Governance provisions as specified in Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clause (b) to (i) of sub regulation (2) of regulation 46 and Para C, D and E of Schedule V shall not apply, in respect of **the listed entity, having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty five crore, as on the last day of the previous financial year.**

Please take note that as per the latest Audited Accounts of the Company as at March 31, 2024, the paid up equity share capital of the Company is Rs. 4,60,87,000/- (Rupees Four Crores Sixty Lakhs and Eighty Seven Thousand Only) and net worth of the Company is Rs. 4,871.10 Lacs/- which is below the threshold limit as specified under the said regulation.

Therefore, Regulation 15(2) and provision of Regulation 23(9) and 24(A) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended are not applicable to our Company.
